**NOTICE: REDUCED LOAD REGULATIONS**

As outlined in the Highway Traffic Act, and pursuant to City of Orillia Traffic By- Law No 2007-55 (Schedule "21"), reduced loading will be in effect on certain roads under the jurisdiction of the City of Orillia at **12:01 a.m. on March 1 and shall remain in effect until 11:59 p.m. on April 30.**

City roads, or sections thereof, subject to reduced loading regulations are as follows:

- Line 15 - from Old Barrie Road north to Bass Lake Side Road.
- Bass Lake Side Road - from Line 15 east to Atlantis Drive.
- Victoria Crescent - from Lankin Boulevard east to cul-de-sac at end of Victoria Crescent (Rutherford's Point).
- Forest Avenue - from Atherley Road south to Victoria Crescent.
- Wilson Point Road - from Huronia Road east to Drinkwater Drive.
- Bay Street - from Fittons Road East north to Drinkwater Drive.

Compliance with the regulation is mandatory and appreciated. Your observance of reduced loads will help protect the roads from damage as the frost comes out of the ground.

6. Bay Street	North limit of Fittons Road East	Drinkwater Drive

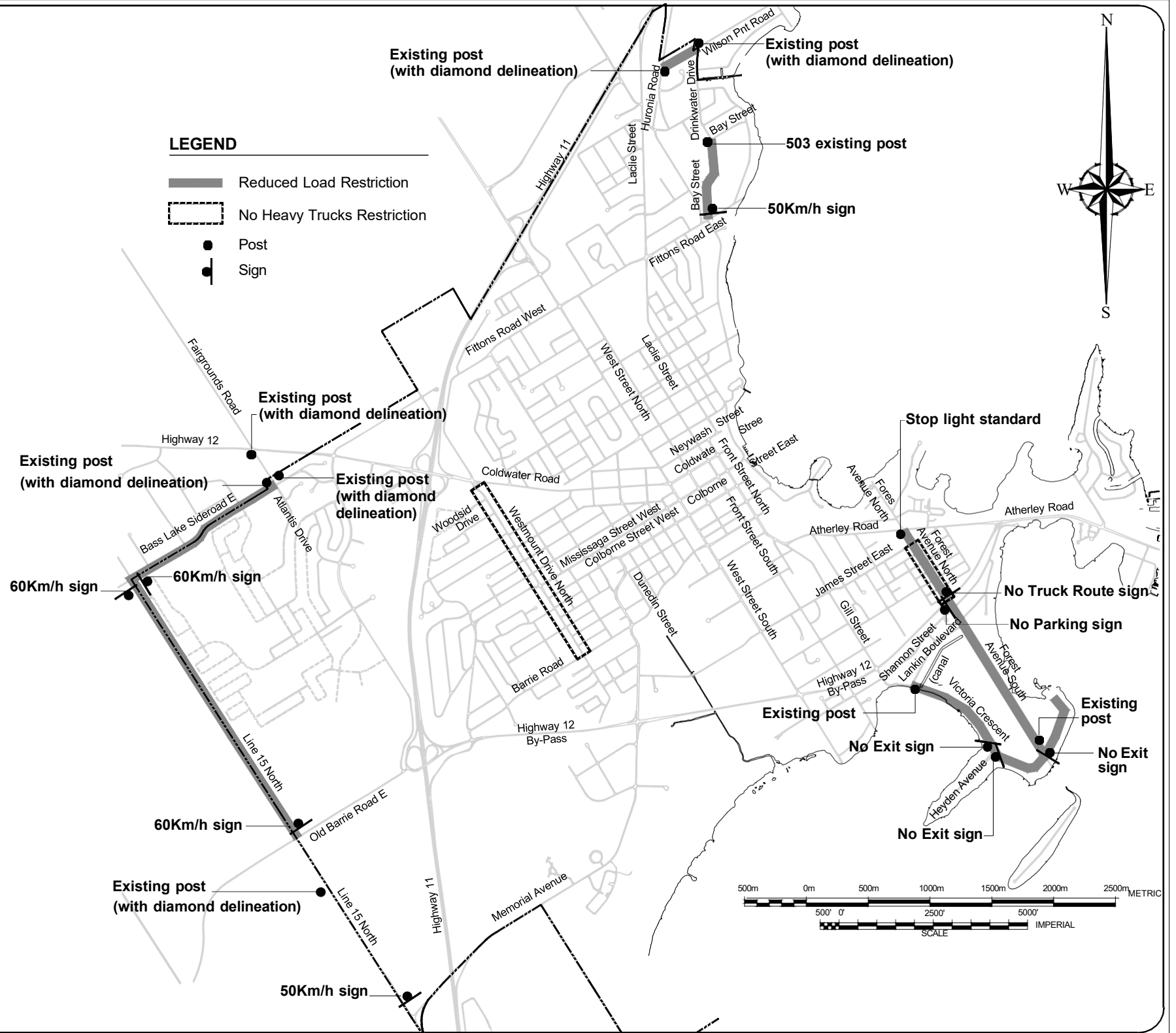
